- Appeal of CORTEVA before the Appeal Administrative Chamber of Marseille
- Favourable decision of the Appeal Administrative Chamber of Marseille (2022)**
- Appeal in cassation before the council of state from CORTEVA
- Negative decision from the Council of State (2024) (decision of the AAC not sufficiently motivated according to the Council of State)
- Dossier again under instruction before the Appeal Administrative Chamber of Marseille

# Requests for cancellation of derogations (art 53 Reg 1107/2009)

AVANZA (Benzobicyclon)	Dossier again under instruction before the Council of State (possible referral to the administrative court Cergy-Pontoise), after unfavourable decision in summary proceedings
GAUCHO 600 FS (Imidaclopride) CRUISER SB (Thiamethoxam)	<b>Favourable decision on the merits of the Council of State</b>

Tébuconazole	Case pending before the European Court of Justice + request for internal review
Flufénacet	Intervention by GF in support of Deutscher Umwelthilfe's application to the European Court of Justice + request for Internal review
Glyphosate	(With PAN E, ClientEarth, Global 2000, PAN Netherlands and PAN Germany ) Case pending before the European Court of Justice + request for internal review
